AGREEMENT AND WAIVER FOR PROSPECTIVE CANDIDATES

As an applicant and prospective candidate in the CGJIPN training program, and in consideration for the right to apply to and, if accepted, participate in the program as a candidate, the undersigned agrees as follows:

I certify that I have at the present time professional liability insurance of at least \$1,000,000-\$3,000,000 of coverage and I promise to maintain such coverage throughout my participation in the training program.

I agree that I will not make any representation in any form, including orally or in writing, to any person, including clients and colleagues, that I am practicing as a Jungian Analyst or analytical psychologist until until such time as I have received a diploma from the CGJIPN and have been certified as a Jungian analyst. I acknowledge that neither acceptance into this training program nor a diploma authorizing me to practice as a Jungian Analyst confers upon me any professional license or legal standing to practice psychotherapy or mental health counseling. For such a professional license or legal standing I must comply with the laws and licensing requirements of the state(s) and local jurisdictions in which I am practicing or will practice.

I agree that if I am accepted into this training program I will not make any representation in any form, including orally or in writing, to any person, including clients and colleagues, regarding my professional status or position or practice, that may infringe on any laws or regulations that govern the practice of psychology, psychotherapy, psychiatry, counseling or any other mental health profession.

I understand that if I am accepted into and participate in the training program, the CGJIPN does not guarantee or promise, either expressly or by implication, that the Institute will pass me from one stage of training to another or that it will ever confer a diploma upon me. I also understand that the Institute, in its sole discretion, acting through its appointed officers and committees has the right to place me on probation or provisional status at any time, and may dismiss me from the training program at any time whether or not I have been placed on probation or provisional status, if I fail to meet the academic, professional, ethical, or psychological standards of the society.

I agree that as a condition of my participation in the training program, that I will forgo and waive any right I may have to assert or file any legal claim of any kind against the CGIPN or the Pacific Northwest Society of Jungian Analysts (PNSJA) or any of its member analysts or representatives arising from the conduct of the training program, or from any action the Institute or Society takes with respect to my training or my continued participation in the program.

I promise to indemnify the CGJIPN and the PNSJA and its analyst members and representatives and hold them individually and collectively harmless from any damages and/or other expenses, including legal fees and expenses, which they may incur as the result of any legal action against me which arises from my practice of counseling, psychotherapy, psychiatry, analysis or other professional activity while I am a participant in the training program.
